Inland Revenue also has an agreement to supply information to Statistics New Zealand for statistical purposes only.

You may ask to see the personal information we hold about you by phoning us on 0800 221 221. Unless we have a lawful reason for withholding the information, we will show it to you and correct any errors.

The information you provide on this form and on the calendar may be the subject of a request by the other party under the Privacy Act 1993 and/or the Official Information Act 1982.
