

Business Transformation: Unclaimed money changes Webinar for unclaimed money holders – April 2021

Greetings everyone and welcome to this webinar.

My name is Anil Srinivasa and I'm a Transformation Account Manager at Inland Revenue working with the financial sector

This is a short presentation that will cover the changes that have recently been implemented to the way unclaimed money is managed by Inland Revenue under the Unclaimed Money Act.

First I'll talk to you about legislation changes that are effective from 30 March 2021 and what they could mean for you as a holder. I'll then talk to changes we have implemented in our system to allow you to manage UCM digitally as a holder.



What is Unclaimed Money?

- Money which has been left untouched by its owner for an extended period of time (5 years) and the person or organisation holding the money has been unable to contact the owner.
- Inland Revenue administers unclaimed money that is subject to the Unclaimed Money Act 1971.
- KiwiSaver money held by Inland Revenue where we have insufficient information to correctly process the money is also classified as unclaimed money.



Unclaimed Money (UCM) is defined as:

- Money which has been left untouched by its owner for an extended period of time and the person or organisation holding the money has been unable to contact the owner. That is, the customer has not interacted with the holder during this period of time.
- Inland Revenue administers unclaimed money that is subject to the Unclaimed Money Act 1971, which has now been updated by new legislation enacted on March 30, 2021.

Some examples of UCM are:

- Deposits in Banks and Financial Institutions
- Money in Solicitors' Trust Accounts
- Unpaid Wages and Employee Benefits (including unpaid Holiday Pay)
- Proceeds of Life Insurance Policies

IR holds a very small amount of KiwiSaver money for which it has insufficient information to process correctly. That is, we are unable to either refund the money to an investor or send it to a provider. Once we have held it for at least 5 years it becomes unclaimed money.

Some types of money are not considered unclaimed under the Act. These include:

- any unclaimed money covered by the Public Finance Act 1989
- amounts payable from Pension and Superannuation funds

The Trusts Act 2019 has its own provision for non-distributable trust property.

Money as defined here is in the traditional sense and the provisions of the Unclaimed Money Act do not apply to Cryptocurrency.





Unclaimed Money (UCM) legislative changes

The Taxation (Annual Rates for 2020-21, Feasibility Expenditure and Remedial Matters) Act 2021 (the "Omnibus Act") was passed on 30th March 2021. This Act amends the Unclaimed Money Act 1971.

The amendments modernise the unclaimed money regime with the aim of simplifying the process of reporting and transferring unclaimed money to the Commissioner of Inland Revenue.

The reforms also recognise that customers are increasingly interacting with their accounts in new ways.

We'll discuss these amendments now. Please note that the changes apply from 30^{th} March 2021.

Key Changes to UCM Act

A number of policy changes have been made to the Unclaimed Money Act 1971. These changes aim to reduce compliance and administration costs and increase the likelihood of successful claims.

The changes aim to modernise the administration of unclaimed money. They also include a number of changes to streamline the administration for holders such as:

- Reducing the length of time which must pass before money may be deemed UCM to five years (previously this was either 6 or 25 years);
- Removing the requirement for holders of UCM to keep a physical register of UCM or make this available to the public, and
- Defining account activity to include online activity and allowing a holder to take an all of institution approach to activity
- Other changes focus on standardising the information that UCM holders will be required to provide to IR
- And in line with modernising unclaimed money, the proposed changes will also see the processes for unclaimed money moved to secure electronic channels.

We've broken the reforms down by topic, as shown on screen. We'll discuss each one of these topics in detail, before moving onto a step by step walk through of the process for registering and filing in myIR.





Change to deeming period

Deeming period is now 5 years for all categories of Unclaimed Money.

If a customer is interacting with any of the accounts they hold with an institution, the 5-year deeming period would \underline{not} begin.

Money can be sent to IR earlier than 5 years in certain cases.



Change to deeming period

- Previously, the length of time which was required to pass before money was deemed unclaimed was either six or 25 years, depending on the type of deposit.
- The reforms have consolidated these two deeming periods into one uniform deeming period of five years. In other words, from 30 March 2021 onwards the rules for unclaimed money have changed and money will be deemed unclaimed when it has been left untouched for 5 years, irrespective of the deposit category.
- The reforms recognise that customers are interacting with their accounts in new ways, and the amended definition of unclaimed money has broadened the forms of activity which will prevent money from becoming unclaimed. Previously, account activity was limited to making a deposit, withdrawal, or offering an instruction in writing. This reflected the common financial practices of the 1970s. To recognise modern forms of account interaction, the Act now refers to owners "requesting information" or "providing instructions" to the holder. This includes customer interaction through internet banking (e.g. where a customer logs into their accounts online and obtains information about their account balance). This also applies to joint accounts.
- To avoid engaging the deeming period, an owner must request information or provide instructions to you, the holder, about the money or another matter. If the owner does not do so for a period of 5 years, the money will be deemed unclaimed. The deeming period commences from the date of the owner's last interaction. So, for example, if money has not been touched since it was deposited with you, the deeming period will begin from the date of the deposit.

- It's important to note that if a customer is interacting with any of the accounts they hold with you, the 5-year deeming period would not begin. This is because accounts such as those that are designed for the goal of long-term savings, such as compounding term deposit accounts, often go untouched for long periods of time.
- Before we move on to our next topic, I would just like to point out that in certain circumstances money can be sent to IR earlier than 5 years. For example – where you hold money for a former client and you cannot locate them.
- Further guidance on these changes is available in our special report which is published on our website.



Monetary threshold of more than \$100

Amounts which are more than \$100 become unclaimed money under the reforms.

For amounts which are \$100 or less, holders may choose to:

- Retain these amounts and use them for other purposes such as a donation to charity or
- Pay them to Inland Revenue as unclaimed money. Where these are received by the Commissioner, they are no longer claimable by the owner.

Amounts retained by your organisation for its own benefit need to accounted for as income.

As is current practice where the amount of unclaimed money you hold for an owner does not exceed \$100, you can choose to pay it to Inland Revenue as unclaimed money or retain it for other purposes.

Under new provisions in the legislation, amounts of unclaimed money that do not exceed \$100 will be removed from the list of unclaimed money held by Inland Revenue and will no longer be claimable by the owner. The Crown becomes the owner of this money.

If you hold onto amounts that do not exceed \$100, they are not deemed as unclaimed money for the purposes of the Act, and your liability to the owner is not extinguished.

You can choose to use sums that are \$100 or less for other purposes, such as a donation to charity or for the benefit of your organisation.

If the money is retained by your organisation for its own benefit it is important to note that IR has issued a public ruling that says that amount will count as income for your organisation.





'Reasonable efforts' to locate owner

You will be required to make reasonable efforts to locate an owner of unclaimed money.

You will no longer be required to keep a physical register of UCM or make this available to the public.

You will no longer be required to collect occupation information.



The reforms require you, as a holder to make reasonable efforts to locate an owner of unclaimed money before sending the money to IR. This marks a move away from the prescribed process of contacting owners under the previous legislation.

The obligation to make reasonable efforts to contact a customer is intended to allow you to use your resources efficiently, so you can actively pursue the avenues of contact which you consider will be most productive.

This requirement is not intended to impose additional compliance costs upon you, and you will not be expected to use avenues of contact that you know will be unproductive e.g. using a phone number that is not current.

You will also no longer be required to keep a physical register of UCM or make this available to the public.

Unclaimed Money

Information collection and transfer

We have standardised the information you need to send to Inland Revenue when you are transferring unclaimed money.

You will be required to supply Inland Revenue with identifying information that you may collect during the normal course of your business and is readily available.

Other information that could be useful:

- IRD numbers but only if you're required to have them for tax purposes
- email addresses
- telephone numbers
- addresses.



Information collection and transfer

The reforms also require that you, as a holder of unclaimed money, provide the Commissioner with any information in your possession or control relating to the owner of the money and the amount.

You will no longer be required to collect occupation information.

This requirement is not intended to impose any added information collection requirements on you. Rather, it just means that you should provide us with any readily available information you hold relating to the owner of the money. Having more information enables us to take good due diligence when confirming the owner of the money.

Information that could be useful, if you have it includes:

- IRD numbers but only if you're required to have them for tax purposes,
- email addresses
- telephone numbers
- Physical or other contact addresses. This includes addresses you hold which are old or invalid as these are helpful for us when people are claiming the money.

More details on the specific data fields to include in the schedule of information you provide to us are outlined in our file upload specification that is published on our website



Filing frequency

Unclaimed money will have a quarterly filing frequency.

Schedules will be expected on a quarterly basis if any money held has aged into unclaimed money during the quarter.

A quarter is defined as a period of three consecutive calendar months ending on the last day of March, June, September, or December.

Reporting period	Transfer to Commissioner by
1 April – 30 June	20 August
1 July – 30 September	20 November
1 October – 31 December	20 February
1 January – 31 March	20 May



Filing frequency

To simplify the rules and processes around unclaimed money, submission of unclaimed money schedules will have a quarterly filing frequency.

As an unclaimed money holder this means you will be expected to file schedules with IR on a quarterly basis if any money you hold has aged into unclaimed money during the quarter.

The reporting quarter is three consecutive calendar months ending on the last day of March, June, September or December.

If quarterly filing does not suit your operational needs you can apply to have your filing frequency changed to a longer reporting period of two consecutive quarters (six months). You can apply by sending us a secure mail from your myIR account.

Any money which becomes unclaimed during a reporting period must be transferred to the Commissioner within one month and 20 days of the end of the reporting period. The table on screen shows the due dates for the filing of information and payment of the money to Inland Revenue for each quarter.

If no money has become unclaimed during the quarter you are not required to file a NIL schedule.



Transitioning to the new regulations

From 30 March, UCM must be filed quarterly – your first schedule is due on 20th August 2021.

A variation process will allow holders to seek an extension.

A 2 year transition period applies to "stock" of unclaimed money created by change in deeming period.

Money which has become unclaimed in the period 1 June 2020 to the date of Royal Assent in 2021 but has not yet been transferred to the Commissioner is also considered as "stock".

The 2 year transition period is provided to all holders.



Money which becomes unclaimed (i.e. satisfies the five-year deeming period) from 30 March 2021 will be subject to the new filing provisions i.e. This must now be reported to us on a quarterly basis with the first schedule due to us by 20th August 2021.

We're aware that some of you may need to update your systems before you are able to comply.

If you are unable to make the transition to the new reporting requirements with effect from 30 March 2021, you may apply to us for an extension to implement the reforms. In effect, this will mean that your first reporting period can be extended to a period of less than two years from 30 March 2021. During your transitional period we will work with you to ensure that your new or updated systems are appropriate. Once the transitional reporting period has ended, normal reporting requirements will apply.

This means that the latest you can delay the filing of your first schedule to is 20th May 2023. That schedule will cover all money that becomes unclaimed during the period 30 March 2021 to 31st March 2023.

You can apply for a variation by sending us a web message in myIR outlining the circumstances that prevent you from meeting the new reporting regime from 30 March 2021



We recognise that due to the change in timelines from the old deeming periods of six and 25 years, to the new five-year deeming period, a stock of Unclaimed Money has been created overnight on the day the act received Royal assent, that is 30 March 2021. This is money that on the day before the date of Royal Assent had not hit the previous deeming periods of 6 or 25 years but had crossed the period of 5 years. A 2-year transition period is provided to all holders to allow you time to identify and file the stock of money that becomes unclaimed due to this change. You will not need to apply to Inland Revenue to avail of this transition period.

Now, we also recognise that the reforms take place nine months into the existing unclaimed money annual filing cycle and that money deemed unclaimed between 1 June 2020 and the day prior to enactment of the new legislation would not usually have been transferred to Inland Revenue until 31 October 2021. You may be holding money that has became unclaimed under the previous regulations, since the cut-off date for filing your last annual schedule with us was 31 May 2020. To assist you in managing the transfer of these amounts, they can be transferred along with the category of "stock" noted above.

In practical terms all such stock of unclaimed money must be transferred to Inland Revenue no later than 30 March 2023. This deadline applies irrespective of any other extension granted to you.



Renewing term deposits

Reforms recognise that it is common for term deposits to be automatically reinvested.

Where the deposit is the only investment which the customer has with you, the 5-year deeming period will not commence until the start of the second term of the renewing term arrangement.

The Act prevents a deposit becoming unclaimed money before the end of a term.

Redeemed units in PIEs

Units in PIEs are not included within the definition of unclaimed money and Inland Revenue will not accept units in PIEs.

Redeemed units can be transferred.



There are some types of unclaimed money which need further clarification, so I'll cover these now, starting with term deposits.

The reforms recognise that it is common for term deposits to be automatically reinvested on similar terms and conditions upon maturity. In such a situation, the standard deeming period would conventionally apply five years from the date the customer last provided instructions to you. Where the deposit is the only investment which the customer has with you, the 5-year deeming period will not commence until the start of the second term (i.e. first rollover) of the renewing term arrangement.

Once the deeming period starts and five years has passed with no interaction, the money will be deemed unclaimed money. To avoid breaking a deposit mid-term, the Act prevents a deposit becoming unclaimed money before the end of a term.

Moving on to units in PIEs – we're aware that some PIE fund managers choose between transferring unclaimed money to the Commissioner under the UCM Act or to the Crown under the new section 149 of the Trusts Act 2019. Although there is merit to allowing flexibility in transferring unclaimed money under both Acts, as noted, units in PIEs are not included within the definition of unclaimed money. However, while Inland Revenue will not accept units in PIEs, it will remain possible for fund managers to transfer the redeemed units (in money) to the Commissioner once it has remained in the holder's possession for the required deeming period (or where the holder wishes to transfer the money earlier).

Further guidance on these changes is available in our special report.



Other changes

- Up to 25 years to claim unclaimed money
- UCM Act is now an Inland Revenue Act
- Taxpayers can choose to use UCM to offset a tax liability
- KiwiSaver Act 2006 amended to align with reforms



The reforms have brought in changes for holders, but there will also be changes which can impact owners – I'll briefly cover some of these now.

There will be a time-bar of 25 years for an owner to claim money from the Commissioner. Previously there was no time limit on an owner's ability to claim money held by the Commissioner. This meant an owner could make a claim for money which had accrued as long ago as the regime's beginning in 1908. Unclaimed money which is more than 25 years old will no longer be claimable. This will mean owners have up to 25 years to claim UCM.

The reforms amend the Tax Administration Act 1994 to allow Inland Revenue to use the existing tax information which it holds in its system to confirm owners' entitlement to their money. This should increase the chance of owners being reunited with their money.

The reforms also insert a new section into the Tax Administration Act. This section allows a taxpayer with an amount of unclaimed money held by the Commissioner to apply all or some of that amount to a tax liability. This option is of course, not compulsory and is available to taxpayers on a voluntary basis.

The KiwiSaver Act 2006 has also been amended to align with the reforms to the UCM Act. This changes the deeming period for KiwiSaver contributions which cannot be administered due to insufficient information, to 5 years before they are treated as unclaimed money.



Unclaimed Money (UCM) digital process changes

We will now talk about the changes to how you manage unclaimed money in myIR



Improved digital process changes

We moved unclaimed money into our new system.

For existing unclaimed money holders this means:

- UCM schedules can be filed via a secure electronic channel no need to email us
- Standardised electronic format to submit your schedule
- Ability to pay us using all available payment methods, including in myIR
- You will have greater visibility of the information and payments you have made to Inland Revenue for unclaimed money.
- Move away from e-mail communication to secure communication via myIR.

On 1 March 2021 we moved the unclaimed money product into our new system. This change saw us move away from paper-based processes towards managing unclaimed money via secure electronic channels.

For existing unclaimed money holders, the 1 March changes mean:

- You will be required to manage unclaimed money in myIR.
- If you have been a holder and passed unclaimed money to us within the last 5 years you may have had an unclaimed money account created for you automatically this includes holders who have had a third party submit UCM on their behalf.
- This account will allow you to submit your schedules under your IRD number, make payments and view previously submitted schedules in myIR.
- You will be required to send your UCM information in a standard digital format. The new process allows you to either file onscreen or upload your file in myIR. As there is a standard format, you are likely to be contacted less often by Inland Revenue.
- If we do contact you, it is more likely to be through myIR. The email address currently used to send schedules to and communicate with Inland Revenue will be shut down. In future you will be able to contact us by web message through myIR.
- Overall, this change will mean you will have greater visibility of the information and payments you have made to Inland Revenue for unclaimed money.





Filing schedules online

There are two methods to submit a schedule to IR:

• Manual entry of the schedule into a table in myIR

Upload an excel file into a table in myIR.

A template for the excel file and more information on the upload file specifications can be found on our website.



Filing schedules online

In order to submit your schedule, you or your tax preparer will need to navigate to the Unclaimed Money Holder account in myIR and find the link to submit a schedule.

There are two methods to submit a schedule to IR:

- Manual entry of the schedule into a table in myIR
- Upload an excel file into a table in myIR

The manual entry option may be easier if the number of records in the schedule is small. Otherwise, uploading an excel file of the schedule would be the most appropriate method.

The file formats accepted are .xls or .xlsx only

There are some guidelines on what columns should be included in your excel file and the expectations for each value e.g. money type and money source

How to register

Now I'll take you through a couple of demos. The first will be on how to register for an unclaimed money account in myIR and the second will be on how to submit a schedule through myIR.

We have set up unclaimed money accounts for most holders. You only need to register if you don't already have a UCM account set up under the IRD number of the entity which is the holder of the unclaimed money.

You will need to grant access to the UCM account to other users who may need to access it to file schedules. This is similar to granting access to any other tax type in myIR

The two URL's on screen will take you to steps on how to manage myIR access. The first is for creating a new logon, the second walks you through updating account access and permission levels for myIR logons in your business.



How to submit a schedule

Now I'll take you through how to submit a schedule – including setting up a direct debit for the first time. If you simply want to test that your file is in the correct format you can follow these steps too – I'll tell you during this demonstration where to stop in the process if you are only testing your file format and not completing a full submission.

Once you have corrected the errors and selected next you will be presented with your summary of schedule information.

As I mentioned earlier if you were just wanting to test your schedule to see if the information would be accepted you can select 'cancel' at this step.

You will have the option to set up a payment as part of your submission. This option will allow you to set up a direct debit.

I'll show you the process for both options – I'll start with what you will see if you do not want to make a payment. If you don't want to make a payment, simply select no and click next.
