Voluntary agreement details

Your agreement must be:

- for a child who is under 18 years of age or 18 years of age and enrolled at and attending a registered school in New Zealand or an overseas school, a New Zealand citizen or ordinarily resident in New Zealand, is not financially independent and not living with another person in a marriage, civil union or de facto relationship
- for regular payments, and for at least \$10 per week (\$520 per year)
- signed by both the liable parent and receiving carer.

Agreed payments will be collected from the liable parent and passed on to the receiving carer monthly.

If you have a separate written agreement please attach a copy to this form.

If a child does not have an IRD number, you'll need to apply for one. You can do this by completing an IRD number application - resident individual - IR595 form.

If there are more than three children, please write their details on the back of this form.

Notes about voluntary agreements

- If the receiving carer is getting an unsupported child's benefit they can only register a voluntary agreement if the amount is
 equal to or more than the amount payable under a child support formula assessment.
- If another person is also a carer of the child or children in a child support formula assessment, they must agree to cancel
 the child support formula assessment. This can be done by all carers of the child by completing a Cancellation of child
 support IR107 form.

- another country, if we have an information supply agreement with them
- Statistics New Zealand (for statistical purposes only).
