When to use this form

Use this form if you want to estimate your income. You can estimate:

- if you expect your income this year will be at least 15% less than the income used in your child support assessment
- you've already estimated and you need to change your estimate.

At the end of the child support year we will compare your estimate to your actual income and reassess your child support.

Notes about income

New Zealand income

- You need to include all your taxable income in your estimate unless it is income from a superannuation fund. For example, KiwiSaver.
- Tax losses from a previous year cannot be included to reduce the income in your estimate. These are ignored for child support purposes.

Overseas income

- If you have income from a country without income tax you must still tell us about this income.
- Tell us about your overseas income in the currency you earn it. We will convert it into New Zealand dollars.
- If you have both New Zealand and overseas income, we will add the amounts together after we convert your overseas income to New Zealand dollars.

Year-to-date income

- Year-to-date income is the income you have received from 1 April to the last day of the month prior to completing this estimate. For example, if you are completing your estimate in July 2026 your year-to-date income is your income for the period 1 April 2026 to 30 June 2026.



Estimated income

Estimated income is what you expect you will receive.

If you are completing this form before 1 May 1 April 2026 – 31 March 2027:

- estimate your income for 1 April 2026 – 31 March 2027.

If you are completing this form on or after 1 May 2026:

- estimate your income from the 1st day of the month in which you are estimating until 31 March 2027.

For example, if you are completing your estimate in July 2026 your estimated income is the income you expect to receive from 1 July 2026 to 31 March 2027.

Your year-to-date and estimated income amounts need to be accurate as we will compare them to your actual income at the end of the year and we will reassess your child support.

What happens next?

- If your estimate is accepted, we will reassess your child support and send you a new letter to let you know your new child support assessment.
- After the end of the year we will compare the income you estimated with what you actually earned and reassess your child support if necessary.
- If we cannot accept your estimate, we will send you a letter explaining why we have declined it.

Privacy

Meeting your child support obligations means giving us accurate information so we can assess your liabilities and entitlements under the Child Support Act 1991.

We may also exchange information about you with:

- some government agencies
- another country, if we have an information supply agreement with them, and
- Statistics New Zealand (for statistical purposes only).

You can ask for the personal information we hold about you. We will give the information to you and correct any errors, unless we have a lawful reason not to. Find our full privacy policy at ird.govt.nz/privacy
