

Tax due date calendar 2026 - 2027

- 1** Employer deduction payment due date for employers who deduct less than \$500,000 PAYE and ESCT per year.
- 2** Employer deduction payment due date for employers who deduct \$500,000 PAYE and ESCT or more per year
 - **20th of the month**
Payment due for deductions made between the 1st and 15th of the same month.
 - **5th of the month**
Payment due for deductions made between the 16th and the end of the previous month.
- 3** GST return and payment due
- 4** Provisional tax instalments due for people and organisations who file GST on a monthly or two-monthly basis, or are not registered for GST
- 5** Provisional tax instalments due for people and organisations who file GST on a six-monthly basis
- 6** Provisional tax instalments due for people and organisations who use the ratio method
- 7** End-of-year income tax payment
 - **7 April 2026**
2025 end-of-year income tax due for clients of tax agents (with a valid extension of time)
 - **7 February 2027**
2026 end-of-year income tax due for people and organisations who do not have a tax agent
- 8** Income tax return
 - **7 July 2026**
2026 income tax return due for people and organisations who do not have a tax agent or extension of time
 - **31 March 2027**
2026 income tax return due for clients of tax agents (with a valid extension of time)
- 9** Quarterly FBT return and payment due
- 10** Annual FBT return and payment due
- 11** Income year FBT return and payment
 - **7 April 2026**
2025 income year return and payment due for clients of tax agents (with a valid extension of time)
 - **7 February 2027**
2026 income year return and payment due for people and organisations who do not have a tax agent

Notes

- If a due date falls on a weekend or public holiday you can file or pay on the next business day without incurring penalties.
- All payment and return filing due dates shown are for people and organisations with a March balance date.
- Due dates for payday filing are not shown on this calendar as they vary. For more information, including when to file, go to ird.govt.nz/employing-staff
