Kei te mārama mātau e hāra te taake i te kaupapa tuatahi kei tō hinengaro i muri mai i te pāpono o tētahi āhuatanga kino, ohotata rānei. Heoi, ka taea e mātau te āwhina atu ina ka whakapā mai koe ki mātau ki te kōrero mō ō māharahara, pātai hoki mō te whakamāmā taake.

Mehemea ka pāngia koe e tētahi pāpono takakino, ohotata rānei, arā ka pāngia tō āheinga utu taake, tō whiwhinga utu rānei, ka wātea pea ki a koe ko te whakamāmātanga taake, ko te āwhina ā-pūtea rānei kei runga i ngā āhuatanga o tō noho whaiaro me taua pāponotanga anō.

Ko te tāpaetanga tōmuri i te puka taake me ngā whiunga utu tōmuri

Mehemea kāore koe i āhei ki te tāpae i te puka taaake i te wā e rite ana, he mea nui tonu te whakapā mai me te kōrero mō ō kōwhiringa. Kāore e taea e mātau te tuku whakaroanga mō ngā whakahokinga GST me te PAYE, engari ka taea pea ngā whiunga mō te whakahoki tōmuri te whakakore. Ki te tae atu tētahi reta ki a koe e kī ana kua takaroa tō puka taake, he mea nui tonu kia kaua koe e waiho kia tārewa, engari me whakapā atu ki tō āpiha taake, ki te Tari Taake rānei hei tōna wā ka taea.

Tērā ētahi āhuatanga e whakakorehia ai ngā whiunga mō te utu tōmuri nā runga i te pā mai o te pāpono takakino, ohotata rānei.

He taake e tārewa tonu ana

Child support

Mehemea kua rerekē te whiwhinga utu, te āhua noho rānei o tō whānau, tērā pea ka whai pānga tēnei ki ō āheinga, ki ō utu rānei. Mehemea he māharahara ōu, he pātai rānei, mehemea rānei kei te raruraru koe ki te utu taake hei ngā rā e rite ana, me waea mai ki a mātau i 0800 221 221.

Ngā Takuhe Taake i Te Mahi mō ngā Whānau (Working for Families Tax Credits)

Ka taea te utu te takuhe taake i Te Mahi mō ngā Whānau (Working for Families) i ia wiki, i ia rua wiki, hei te mutunga rānei o te tau taake. Mehemea kua pāngia tō whiwhinga utu, te āhua noho rānei o tō whānau e tētahi pāpono takakino, ohotata rānei, me whakahou mai koe i ō taipitopito whānau ki myIR i ird.govt.nz

He takuhe, he utu whakamāmā (mō ngā tāngata takitahi me ngā whānau)

I tētahi pāpono takakino, ohotata rānei, tērā pea ka wātea ētahi utu whakamarumarū i te Hiranga Tangata. Ka taea ngā utu whakamarumarū nei te whakamahi hei utu i ngā momo nama pēnei i te kai, i te moenga, i te kākahu, i te noho whare, ā, he utu ēnei e pā ana ki te noho whaiaro o te whānau, kāore he pānga ā-taake ka hua mai mehemea ka whakawhiwhia koe ki ēnei momo utu whakamarumarū.

Kāore hoki he pānga ā-taake ka hua mai mehemea ka whakawhiwhia atu tētahi utu whakakapi ngaronga utu ki te tangata ka rite tonu te whakawhiwhia ki te utu mahi, ki te utu takuhe rānei. Mehemea kei te mahi koe mōu tonu, ka whakamahia pea koe ki te utu taake mō tēnei utu – me tirotiro atu ki te wāhanga “ngā takuhe me ngā utu whakamāmā mō ngā pakihi” kei raro nei.

Ko Kiwisaver

Ki te pāngia koe e te pāpono takakino, ohotata, ka taea e koe te whakatārewa ngā tukunga pūtea Kiwisaver, ka taea rānei pea te tono kia tangohia atu tētahi wāhanga nā runga i te taimaha. Ngā whakatau tata mō te taake tārewa / he whakatau tata hou

Ka taea pea e koe te whakatau tata, te whakahou rānei te whakatau tata o tō taake tārewa mehemea kua rerekē ō whiwhinga nā te pāpono takakino, ohotata rānei. Ka taea e mātau te whakarite he whakahokinga pūtea wawe mehemea kua nui rawa te utu i te taake tārewa.

He tiwhikete awere, he taumata taake e whāiti ana

Mehemea kei te whai mahi kirimana koe i tenei wā, ka

Ko ngā takuhe me ngā utu āwhina ka whakawhiwhia ki tētahi pakihi, me whakauru atu ki ngā whakawhiwhinga utu a te pakihi i tō puka taake GST i te nuinga o te wā.

Mō te taake whiwhinga utu, ko te whakatau tika mō te takuhe me te utu āwhina ka whakaritea i runga i te tangata, i te whakahaere rānei nāna i utu te takuhe, te utu āwhina rānei me te kaupapa o te takuhe, o te utu āwhina.

Ka taea he kōrero anō mō ngā takuhe me ngā utu āwhina te rapu ki tā mātau pukapuka **Grants and subsidies (IR249)**.

He utu inihua

Mehemea kua rēhita koe mō te GST (e herea ana rānei ki te rēhita), ā, ka riro i a koe tētahi utu inihua e pā ana ki ngā mahi ka taea te taake, ko te tikanga me aro atu ki te GST i runga i tēnei utu.

Mehemea e pā ana te utu ki ngā rawa whakahaere pakihi kua ngaro (he kararehe, he rawa hoko), mō te rawa ka whakapautia (he hei, he rawa mata) mō te ngaro whiwhinga utu, huamoni rānei, he whiwhinga tēnei ka taea te taake mō roto i ngā tikanga taake whakawhiwhinga.

Mehemea e pā ana te utu ki ngā haupū rawa ka taea te whakaheke uara (he hēti, he rawa hanga, he umuuku rānei), ko te tikanga me kaute te rahi inihua ki ngā nama e hono ana, pēnei i ngā whakatikatika me ngā whakarerekētanga ki ngā uara pukapuka taake o te rawa māna pea ka whakaiti i ngā kerēme whakahekenga uara muri atu, māna rānei ka hua mai he whakahokinga i te whakahekenga uara.

Te Hōtaka Kapewhiti Pakihi Iti (pūtea taurewa)
