

## IRD number application - offshore individual

#### For full details go to ird.govt.nz/offshore

#### Only use this form if you're not in New Zealand.

If you're physically in New Zealand at the time you're applying, use Inland Revenue's online IRD number application service, or the IRD number application – individual currently in New Zealand - IR595 form.

#### To apply for an IRD number for you

You'll need each of these:

- photographic identification, such as a passport or an overseas driver licence
- proof of your current address, which may include:
  - a letter from your utilities company
  - national identity card or overseas driver licence (if not used as photographic identification)
- · proof of your intended activity in New Zealand
- proof of your fully functional New Zealand bank account or proof that customer due diligence has been completed
- proof of your taxpayer identification number (TIN) or reason why you do not have a TIN

#### To apply for an IRD number for a child

If you're applying for a child who is in your care and they're under 16, you must provide the following.

#### For you:

- a form of photographic identification refer to "To apply for an IRD number for you".
- proof of your current or most recent previous address refer to "To apply for an IRD number for you".

#### For the child:

- a document which shows the relationship between you and the child, for example
  - a full birth certificate
  - court documents showing the child's and caregiver's names, for example adoption papers, parenting orders, guardianship orders
- Documentation as stated in the section To apply for an IRD number for you.

Only send legible copies of supporting documents and photo ID.

All attachments must be certified except for the proof of New Zealand bank account or customer due diligence.

If the documents you provide are in another name, you must provide a legible copy of the document that confirms how your name was changed, for example, marriage certificate, official name change certificate.

#### If your request is urgent then clearly state the reason why in your email.

We aim to process your application within 8-10 working days from when we receive it. We'll text, email or post your IRD number to you. It can take 20 working days to arrive if you ask us to post it.

DO NOT post your application to Inland Revenue.

#### **Privacy**

Meeting your tax obligations means giving us accurate information so we can assess your liabilities or your entitlements under the Acts we administer. We may charge penalties if you do not.

We may also exchange information about you with:

- some New Zealand government agencies
- another country, if we have an information supply agreement with them
- Statistics New Zealand (for statistical purposes only).
