Thank you for your request made under the Official Information Act 1982 (OIA), received on 27 January 2025. You requested the following:

Average weekly amount spent on ECE (based on invoice amounts entered in on Family Boost applications) nationally and then broken down by region

On 7 February 2025, you clarified your request to be for the average amount spent for a quarter, rather than weekly. You also confirmed that information is to be based on the "approved total invoice amount" and "claims approved".
