Thank you for your request made under the Official Information Act 1982 (OIA), received on 5 December 2024. Your full request is attached as **Appendix A**.

I have decided to withhold the copies of the specific contracts, agreements or communication relating to the contracts between Inland Revenue and the requested suppliers in full under section 9(2)(b)(ii) of the OIA, as release of this information would be likely to prejudice the commercial position of the person who supplied, or who is the subject of the information.

Inland Revenue does not have any contracts with any of the requested suppliers' associated entities. This part of your request is therefore refused under section 18(e) of the OIA as the information requested does not exist.



Part 2: Financial transactions

To supply the financial transactions with the requested suppliers to the specificity requested would be likely to prejudice the commercial position of the entities involved. Therefore, I have decided to withhold this information under section 9(2)(b)(ii) of the OIA.

As required by section 9(1) of the OIA, I have considered whether the grounds for withholding the information requested is outweighed by the public interest. In this instance, I do not consider that to be the case.

I am, however, able to provide the total amounts paid to these companies in the last four years in **Table 1** below.
