Thank you for your request made under the Official Information Act 1982 (OIA), received on 8 April 2025. You requested the following:

... copies of all submissions made in relation to the Taxation and the not-for-profit sector. Including if the submissions are made by non-natural persons their names should be made available.

Inland Revenue officials are in the process of reviewing the submissions received on the proposed changes to the charities and not-for-profit sector, therefore, I am refusing your request for copies of all submissions under section 9(2)(f)(iv) of the OIA, to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by minister and officials.

Once Inland Revenue officials have concluded reviewing the submissions and discussed the findings with Ministers, these submissions will be published on Inland Revenue's Tax Policy website (<a href="taxpolicy.ird.govt.nz">taxpolicy.ird.govt.nz</a>), subject to redactions under the OIA.

Inland Revenue received 904 submissions. Of these submissions, 2 were made anonymously, and 19 submitters requested that their names be withheld. Additionally, 78 submissions were made using a form created by a single organisation; for ease of collation, these submissions have been attributed to that organisation.

I am releasing, enclosed as **Appendix A**, the name of 806 submitters.

I am withholding the names the 19 submitters under the following sections of the OIA:

- 9(2)(a) of the OIA to protect the privacy of natural persons, and
- 9(2)(ba)(ii) to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely otherwise to damage the public interest.

As required by section 9(1) of the OIA, I have considered whether the grounds for withholding the information requested is outweighed by the public interest. In this instance, I do not consider that to be the case.

## Right of review

If you disagree with my decision on your OIA request, you have the right to ask the Ombudsman to investigate and review my decision under section 28(3) of the OIA. Publishing responses increases the availability of information to the public and is consistent with the OIA's purpose of enabling more effective participation in the making and administration of laws and policies and promoting the accountability of officials.
