Your email of 21 September 2021 to the Minister of Finance, Hon Grant Robertson, about the resurgence support payment (RSP), has been referred to Inland Revenue for reply. I also refer to our telephone conversation of 1 October 2021 about your request for information on the RSP.

As Inland Revenue requires taxpayers to supply a physical address our system allocates these addresses to regions based on proximity. The main city within the region, in this case Timaru, is used as the regional descriptor in the tables. As businesses may operate internationally, nationally or in a range of regions, the allocation is only an approximate indicator of the location of business activity.

The first set of tables in *appendix 1* shows the number of applications received and the total amount applied for by the businesses in the Timaru region. The second set of tables in *appendix 2* shows the number of applications that we have approved and paid for the Timaru region.

The tables are broken down into the three RSPs that became available from 24 August 2021. The first table in each set provides the totals for all three RSPs for the Timaru region. Both sets of tables include information held as of 12 October 2021.
